Dear Town Clerk Dahill:

The Carver Earth Removal Committee voted to approve an earth removal permit for property Off Federal Rd, Map 131 Lot 2-4 subject to the following conditions:

- 1. Removal not to exceed 1,401,800 cu. yards and shall be confined to the area shown on the plans submitted with the application. No change to said plans shall be made unless the applicant appears before the ERC for an amendment to this permit.
- 2. The project to be completed in Phases, starting in the northern most area of the property and proceeding southward. There will be no work performed on the next phase until the prior phase is substantially completed and the ERC or its agent has inspected the work and issued a Notice to Proceed for the next phase.
- 3. Hours of operation: Monday Friday 7:30 am 4 p.m., Saturday 7:30-12:00. Trucks are to take extra caution during the following times due to school buses: Monday-Friday 6:15 am 8:15 am and 2:00 pm 3:30 pm.
- 4. Inspection fees will be paid per quarter to the Town of Carver at the rate of \$0.10 cents per cubic yard, to be submitted quarterly with signed form. Please note that Transmittal Tally Sheets are due monthly (See Attached).
- 5. Truck direction is onto Federal Rd. Trucks leaving the site, 80% must turn left and take Federal Rd to Farm to Market Rd, and straight to Tihonet Rd, as spelled out in the

application, and 20% of the traffic may go right to Cranberry Road, turn left, and follow Cranberry Rd to Tremont St.

- 6. There will be no staging of trucks on any public road.
- 7. The maximum number of truckload trips per day not to exceed 50 round-trip.
- 8. Dust mitigation measures shall be implemented by all drivers to ensure that all public roads shall be kept free of dust and dirt. Asphalt, recycle material, "stone dust" or equivalent is to be used to cover the first 100 feet of roadway within the project site at each entrance and exit.
- 9. White noise back-up alarms will be installed on all equipment working in conjunction with the earth removal project.
- 10. The approach apron at each entrance and exit from the project site shall be sufficiently wide to be suitable for trucks to pass, so there is little impact on traffic.
- 11. Install stop sign at each exit point from the project site prior to proceeding onto any public road.
- 12. This permit is valid for one year from date of issuance of this permit and is subject to extension annually for up to four (4) additional extensions upon approval of the Earth Removal Committee.
- 13. This permit is conditioned upon compliance with the Town of Carver Earth Removal Bylaw and the Truck Rules of the Carver Earth Removal Committee. Copies of the ERC's Truck Rules shall be distributed to all drivers.
- 14. By accepting this permit, the applicant consents to inspections at reasonable time by the Earth Removal Committee and its agents.
