Dear Records Access Officer:

This is a request under the *Public Records Law*, *M.G.L.* c.66, §10 from Save the Pine Barrens, Inc. ("STPB")/Community Land & Water Coalition.

Please provide a response and these records to us, preferably in an electronic format, within the time required by the *Public Records Law*.

This request is for records relating to the Plymouth Regional Economic Development Foundation, Inc. ("Plymouth Foundation"). The Plymouth Foundation's IRS 990 Tax Returns from at least 2012 to 2022 state that it receives payments from the Town of Plymouth. This request seeks all records relating or referring to those payments, as described below. The period covered by this request is January 1, 2001 to the present.


## STPB requests:

1. All records of monetary compensation paid by the Town of Plymouth to the Plymouth Foundation for Foundation employees or contractors providing services to the Town of Plymouth, including but not limited to copies of payroll transfers, salary payments, independent contractor payments, payments for services, checks, and invoices.

- 2. All job descriptions or records describing the tasks performed by the Plymouth Foundation for the Town of Plymouth.
- 3. All records showing the tasks performed by the Town's "director of economic development" for the Foundation.
- 4. All Requests for Proposal, solicitations, contracts or other records relating or referring to the Town's solicitation of services for economic development services "and such related services" as described in the Plymouth Foundation's IRS 990-PF form for 2022 as stated below in this excerpt from the Foundation's 990.

The disclosure of the records requested here are in the public interest.

If you require any additional information to support the grant of a public interest fee waiver, please notify me and STPB will gladly provide it. If you determine that a fee waiver is not justified in this instance, please notify me prior to complying with this request.
